DURING THAT TIME, IN 2019, WE SAVED 1738 ANIMALS FROM HIGH KILL SHELTERS THROUGHOUT SOUTH CAROLINA, NORTH CAROLINA, VIRGINIA, MARYLAND, TEXAS, MISSISSIPPI, FLORIDA, HAWAII AND PUERTO RICO. WE SUCCESSFULLY EVACUATED ANIMALS FROM THE PATH OF HURRICANE FLORENCE AND ASSISTED IN EVACUATING ANIMALS FROM THE PATH OF HURRICAN DORIAN.
