LUCKY DOG'S ADOPTIONS REMAINS THE CORE OF OUR ANIMAL PROGRAMS. LIKE MANY ORGANIZATIONS NATIONWIDE, LUCKY DOG SAW A DECREASE IN LARGE DOG ADOPTIONS IN 2024, BUT AN INCREASE IN CAT ADOPTIONS. FOR THE FIRST TIME SINCE OUR FOUNDING, ADOPTIONS FOR BOTH SPECIES WERE ALMOST EQUAL. WE ADOPTED OUT 1,432 DOGS AND 1,631 CATS - 2,795 ANIMALS IN TOTAL (INCLUDING 2 GUINEA PIGS). DURING THAT TIME, WE SAVED 2,614 ANIMALS FROM HIGH KILL SHELTERS THROUGHOUT SOUTH CAROLINA, NORTH CAROLINA, VIRGINIA, MARYLAND, TEXAS, MISSISSIPPI, FLORIDA, AND PUERTO RICO. BY THE END OF 2024, LUCKY DOG HAD SAVED MORE THAN 30,500 ANIMALS SINCE OUR FOUNDING IN MAY 2009. THE VAST MAJORITY OF THESE DOGS AND CATS WERE PLACED IN CAREFULLY SCREENED, LOVING ADOPTIVE HOMES.
